Diplomacy:Essentials and Dynamics

Due to the growing number of participants in globalized relations (States, International Organizations, as well as NGOs, transnational companies, the media, etc.) the focus of traditional diplomacy is widening:

- internalization of diplomacy and internationalization of domestic affairs,
- flexibility and pragmatism,
- communitarianism versus reciprocity,
- culture and language,
- symbolism.

Diplomacy is transforming and expanding its role as the method of interstate relations to a general instrument of communication among globalized societies. Adapting to globalization the practice of diplomacy is shared by non-state participants, thus becoming privatized and popularized. With the strife for common values, the finality of international interaction moves beyond national interest towards communitarianism.

International law governing foreign relations can be strengthened through judicial review by national courts. The legal foundations of diplomacy are provided in particular by the Vienna Conventions on Diplomatic and Consular Relations. Working on the interface of diplomacy and academia, this practitioner's seminar combines an insider view into innovation and change of the diplomatic process with a concise interdisciplinary academic analysis.

The interdisciplinary, career-orientated seminar by an active diplomat in cooperation with the German Foreign Office is preparing for innovative international tasks and deals with topical problems of diplomacy using practical cases and experience as well as relevant literature.
