## Who is giving advice?







## If you received a penal order

You've received a penal order and are afraid to consult a lawyer because you might not be able to afford it? Or you don't understand the content?

You want to appeal the penal order but don't know whether it's worth it? You feel wrongly punished? You don't understand for what you have to pay in addition to the penalty? You assume you're guilty, but find the punishment is too much? You missed a deadline? You wonder if deferred payment is possible? Could you ask for time to pay or labor instead of punishment? You have other questions?

We offer a **pro-bono** advice for people who have received a penal order and want information regarding their rights.



### Most important:

Save the **yellow envelope** in which the penal order was served. It will indicate the date on which the appeal period begins. **The deadline is after only 14 days!**

After receiving a penal order, please **come to the consultation center as soon as possible** during our consultation hours and bring the penal order, the yellow envelope and, if possible, documents relating to your income situation (e.g. permit notice, pension notice, etc.).

## What we can offer

We can offer **support and advice** e.g. with:

- See whether it makes sense to resist the penal order;
- Lodging an **appeal**;
- Verification that the **amount of the daily rate** has been correctly determined;
- Request for **payment in instalments**;
- Request for **labor instead of punishment**;
- Prevention of **substitute imprisonment**;
- Application for **restoration** (to reset the deadline for the appeal);
- Proceedings **after appeal**.

Of course we can also cover other consultation areas.
