THE PROGRAM

Indiana University Maurer School of Law has been granting graduate degrees to international lawyers for more than 100 years, in LLM, MCL, SJD, and PhD programs. Our internationally respected Master of Laws (LLM) program offers highly qualified and academically outstanding students the opportunity to pursue advanced legal studies in a rigorous but supportive environment. Indiana Law is a top-ranked law school in the United States, and the LLM program has earned top ratings in the areas of academics, best law school experience, career planning, and best value.

Indiana Law's LLM degree is primarily for international students with a first degree in law, and it requires at least one academic year in residence. We currently offer both the traditional LLM (24 credit hours) as well as an LLM with thesis (30 credit hours) for students planning to pursue doctoral studies. We also offer six areas of specialization for the LLM degree.



SIX SPECIALIZATIONS

As an Indiana Law graduate student, in addition to earning a general LLM, you can choose from several specialized areas of study that suit your interests and career goals. We currently offer specializations in:

- **Business and commercial law**
- **Intellectual property law**
- **Financial regulation and capital markets**
- **American law with focus on US bar exam**
- **Information privacy and cybersecurity law**
- **International and comparative law and globalization**

COSTS AND SCHOLARSHIPS

Tuition and fees for the LLM degree (24 credit hours) is approximately \$46,375. The total estimated cost for one year, including tuition and fees, room and board, health insurance, and miscellaneous expenses, is \$62,650. Considering the low tuition and cost of living, Indiana Law is often less expensive than other schools. In addition, every applicant is considered for one of our **Graduate Legal Studies scholarships**, which range up to 50% of tuition costs. Scholarship decisions are based on academic and professional merit and financial need, as well as a number of other factors, including geographic diversity and relationship with our partner institutions.

APPLICATIONS ARE NOW OPEN

We invite you to apply to the Indiana University Maurer School of Law's prestigious LLM program. We offer August or January enrollment, or students may be considered for the summer-start program, which includes Legal English and an intensive course on Introduction to American Law.
