### Requirements and Assessment (FU Berlin only)

This seminar targets undergraduate students of law or political science and is open to Erasmus and graduate students in these fields. The maximum number of participants from the Freie Universität is 16.

All seminar papers can be written in English or German, all oral presentations will be in English. The length of the paper shall not exceed 3.000 words (without footnotes, bibliography, and table of contents). The oral presentation must not exceed 20 minutes at the most and is followed by a discussion. Assessment: paper (80%), presentation (20%).

Each topic shall ideally be assigned to one student from the Freie Universität Berlin, and to one student from Cambridge. This will lead to the articulation of different viewpoints and enrich the discussion.
