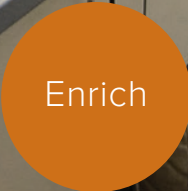

## UC Hastings LL.M. Program.

Our LL.M. program offers a vibrant mix of academic coursework, professional development opportunities, and community-building social events. Each year, new LL.M. candidates find a stimulating and nurturing home at UC Hastings as they prepare for the next phase of their careers.

We keep our LL.M. cohort intentionally small, typically consisting of 25 – 40 students from around the world. As an LL.M. student, you will be integrated into the law school with our J.D. students, providing you opportunities to make lasting friendships, build professional networks, and share your unique ideas and legal perspectives. Students who excel in the LL.M. program can apply to transfer to the J.D. program and, if admitted, can complete their J.D. in an additional two years.

Our Global Programs team supports LL.M. students by providing extensive advising services designed to help students tailor the LL.M. program to their interests and achieve their academic goals. Furthermore, our Career Development Office offers professional development workshops and staffs a designated counselor for our LL.M. students. LL.M. students also have access to bar passage support services to promote student success.

We are proud to be one of the few law schools in the United States that has on-campus housing available to our LL.M. students. In addition, we are pleased to be able to offer both merit- and need-based scholarships to our LL.M. students.

### APPLICATION PROCESS

### APPLICATION CHECKLIST

- Applicants must submit an application, personal statement, transcripts, two letters of recommendation, and a resume through LSAC. Please visit [www.lsac.org](http://www.lsac.org) to create an account. Nominees from partner schools are invited to contact us for a paper application.
- Applicants must use the LSAC Credential Assembly Service (CAS).
- UC Hastings strongly recommends (but does not require) that applicants register for the LSAC CAS LL.M. International Transcript Authentication and Evaluation service.
- A minimum iBT TOEFL score of 90 or a minimum IELTS score of 7 is strongly preferred.
- \$75 Application fee payable through LSAC (fee waivers are available).
